

Resolution SIRGAS 2020 No. 1 November 19th, 2020

Concerning the approval of a new statute for SIRGAS

In consideration of:

- Article 33 of the Statute of SIRGAS, approved by the Directing Council on May the 9th, which establishes that "the decision-making bodies of SIRGAS should review the existing statute at least every eight years and propose those changes that are necessary for keeping the structure and functions of SIRGAS up to date";
- 2. The survey run during the month of December 2019 covering members of the Directing Council and of the Scientific Committee, also the Working Group Chairs, for the purpose of carrying out an assessment of the regional geodesic situation and of the progress made towards the objectives of the SIRGAS Working Groups; and
- 3. The work performed by the members of the Executive Committee, Scientific Committee and Directing Council of SIRGAS during the year 2020 for drafting and reaching agreement on a new proposal for the statute, which gives to the organization a high degree of institutional status among the Member States represented in the Directing Council, aligns its scientific activities with those which the International Geodesy Association proposes and integrates regionally with the Regional Committee of UN-GGIM: Americas;

- 1. Recognize the valuable work performed by all the component bodies of SIRGAS in the development of the new statute; and
- 2. Approve the new Statute, which is attached to this Resolution.



Resolution SIRGAS 2020 No. 2 November 19th, 2020

Concerning the creation of the GRFA Working Group within the framework of the UN-GGIM: Americas Regional Committee

In consideration of:

1. The work performed by the task force established under Resolution 2019/5 of the UN-GGIM: Americas Regional Committee and led by the Authorities of SIRGAS, by which means the document was drafted with the Terms of Reference of the Working Group for the Geodesic Reference Frame for the Americas (GRFA), which supports the implementation of the resolution of the General Assembly of the United Nations "the global geodesic reference frame for sustainable development" (A / RES / 69/266) in the Americas.

- Recognize the valuable work performed by the Authorities of SIRGAS in the development
 of the Terms of Reference of the GRFA Working Group, which will guide the activities of
 the Working Group, and which position SIRGAS as the Pan-American scientific organization
 responsible for establishing the Geodesic Reference Frame for the Americas;
- 2. Support the creation of a GRFA Working Group, to be chaired by the SIRGAS Authorities; and
- 3. Encourage the Member States to participate actively in the activities that the GRFA Working Group runs.

Concerning the approval of the Work Plan of SIRGAS for the year 2021

In consideration of:

- 1. The objectives of SIRGAS and its Working Groups defined in the new Statute of the Organization; and
- 2. The Work Plan of SIRGAS for the year 2021 proposed by the Executive Committee of SIRGAS.

- 1. Approve the Work Plan of SIRGAS for the year 2021; and
- 2. Encourage the Member States to participate actively in the activities that the SIRGAS Working Groups carry out in order to cooperate in putting the 2021 Work Plan into effect.



Resolution SIRGAS 2020 No. 4 November 19th, 2020

Concerning the drafting of a new Joint Action Plan

In consideration of:

- The success of the cooperation activities in progress and the joint projects implemented between PAIGH, UN-GGIM Americas, SIRGAS and GeoSUR, formalized by means of the Joint Action Plan signed initially in 2012 and renewed in 2016, within the framework of the premise of a system for shared responsibilities, avoiding duplicate effort and bringing greater benefits for each partner;
- 2. The fact that the current Action Plan finishes in December 2020;
- 3. The fact that the regional organizations that participate in the Joint Action Plan agree to keep working together in order to make progress towards the creation of an SDI for the region, taking into consideration the Geospatial Information Integrated Framework (IGIF), with its seven fundamental principles, eight goals and nine strategic pathways; and
- 4. The declaration "Better together: Geospatial information for decision-making in the Americas" (also known as the Declaration of Aguascalientes 2020) approved during the Virtual Joint Session of UN-GGIM: Americas and AmeriGEO (held on the 9th of September, 2020) with the aim of strengthening and improving the cooperation between regional organizations and agencies for the use of observations of the Earth; also geographic, statistical, and other kinds of information.

It has been resolved to:

1. Urge the Authorities of SIRGAS to participate in the drafting of a new Joint Action Plan that contributes to the fulfillment of the objectives of SIRGAS concerning the definition of the geodesic reference frame of the Americas.
